

**ORDINANCE NO. 22/2021**  
**of the Rector of the University of Wrocław**  
**of 24 February 2021**

**on the fees for educational services provided at the University of Wrocław for the teaching cycles beginning in the academic year 2021/2022**

Pursuant to Article 23, Section 1 and Article 79, Section 1 of Higher Education and Science Law Act of 20 July 2018 (uniform text: Journal of Laws of 2020, item 85, as amended [Dz. U. z 2020 r., poz. 85, z późn. zm.]), the Rector orders as follows:

§ 1 This Ordinance specifies the fees for the following educational services:

- 1/. for the education of **Polish citizens and foreigners** pursuing part-time studies conducted in the Polish language;
- 2/. for the repetition of classes due to unsatisfactory academic results and for participation in classes not included in the study plan of full-time and part-time studies as well as full-time and part-time doctoral studies conducted in the Polish language for **Polish citizens and foreigners**;
- 3/. for the education of foreigners pursuing full-time studies conducted in the Polish language;
- 4/. for the education and repetition of classes due to unsatisfactory academic results and for participation in classes not included in the study plan of full-time and part-time studies in the English language for **Polish citizens and foreigners**.

§ 2.1 The amount of fees for Polish citizens and foreigners for part-time studies and part-time doctoral studies conducted in the Polish language shall be determined:

- 1/. Appendix **No. 1** at the Faculty of Letters;
- 2/. Appendix **No. 2** at the Faculty of Historical and Pedagogical Sciences;
- 3/. Appendix **No. 3** at the Faculty of Social Sciences;
- 4/. Appendix **No. 4** at the Faculty of Law, Administration and Economics.

2. The amount of fees for full-time and part-time studies as well as full-time and part-time doctoral studies conducted in the Polish language for Polish citizens and foreigners for:

- the repetition of classes due to unsatisfactory academic results,
- participation in classes not included in the study plan,
- the established curriculum differences in the case of changing the form of study or transferring from another institution of higher education,

is specified in **Appendix No. 5** to this Ordinance.

3. The amount of fees related to the education of foreigners pursuing full-time studies conducted in the Polish language is specified in Appendix **No. 6** to this Ordinance.

4. The amount of fees related to the education and repetition of classes due to unsatisfactory academic results and for participation in classes not included in the study plan of full-time and part-time studies conducted in the English language is specified in Appendix **No. 7** to this Ordinance.

5. The amount of fees for full-time studies in the English language financed by external funds is specified in Appendix **No. 8** to this Ordinance.

§ 3 Fees for the education of foreigners pursuing full-time studies in the Polish language as specified in Appendix No. **6** shall not be charged from:

- 1/. a foreigner – a citizen of a European Union Member State, the Swiss Confederation, Norway or Iceland (member states of the European Free Trade Agreement – EFTA) – a party to the agreement about the European Economic Area and their family members residing in the territory of the Republic of Poland;
- 2/. a foreigner who has been granted a permanent residence permit or a long-term resident of the European Union;
- 3/. a foreigner who has been granted a temporary residence permit for a family reunion;
- 4/. a foreigner who has the status of a refugee granted in the Republic of Poland or enjoys temporary protection or subsidiary protection in the territory of the Republic of Poland;
- 5/. a foreigner – a holder of a certificate confirming the command of Polish as a foreign language, at least on the C1 language proficiency level. The only authorisation document is a certificate issued by the State Commission for the Certification of Proficiency in Polish as a Foreign Language;

- 6/. a holder of a valid Pole's Card or a person to whom a decision on the determination of Polish origin has been issued;
- 7/. a foreigner who is a spouse, ascendant or descendant (child, grandchild) of a citizen of the Republic of Poland, residing in the territory of Poland.

§ 4 The amount of fees for foreigners for the courses in Polish as a foreign language attended at the School of Polish Language and Culture for Foreigners is specified in Appendix **No. 9** to this Ordinance.

§ 5 The amount of semester fees for basic physical education classes and the amount of fees for weekend and outgoing classes and sport and recreation camps organised within physical education classes is specified in Appendix **No. 10** to this Ordinance.

§ 6 The supervision of the implementation of this Ordinance shall be entrusted to the Vice-Rector for teaching.

§ 7 The Ordinance shall become effective on the date of its signature.

4. The fee for one semester is half of the annual fee.
